





### SHIPPING CONTAINER MONITORING PROCESS



Device installed inside the container at the point of loading Monitoring from the point of loading to the point of final delivery Any form of container break-in is recorded at all times



Real-time reports via gsm network (stored off-grid)

EyeSeal notifies customs and law enforcement of break-ins








EyeSeal device installed inside the container at point of origin possibly in collaboration with accredited survey company.
